Bellarmine Preparatory School July 26th- August 4th, 2023

The hard work of our team will be a great bridge between us and the community and we will develop a mutual respect that will help provide inroads into a rich cross-cultural experience and first-hand insight into a developing world community.

We are looking for great cultural ambassadors, so please only sign up for this trip if you are willing to step outside of your comfort zone. Most importantly, we ask that you enter into this with a great sense of humility. We want you to be eager to learn and grow in this process as we are entering into a different culture with different values and norms. We want you be quick to listen and slow to speak.

We will not be giving you a detailed itinerary as things are very prone to change with this sort of construction project. But your time will be spent working on the court, taking part in various cultural activities and, most importantly, connecting with the locals.

Community Information

Las Marias is a community nestled up in the mountains of the Coclé province in Panama. They are located 3.5 hours west from Panama city, there are about approximately 160 homes all spread out in the area. The name of the school where the court will be built is C.E.B.G Las Marías, the current enrollment has students from elementary and secondary up until 9th grade. There is one catholic church in town and about 99% of the population is catholic and very participant in the church activities.

The main economic activity of the population is subsistence agriculture. Among the products grown is rice as the main source of food, followed by the cultivation of cassava, Chinese bananas, and corn. Orange and Japanese trees are also produced in this region, the latter being the most abundant. This rural community also works a lot with wood since most of the housing is made of wood (boards) used for rafts, pylon, furniture, bed doors, and hanging bridges (for passages in rivers and streams).



Within the customs, the inhabitants usually carry out work meetings or rice harvests, earning labor, but of course always accompanied by a good gallon of strong corn chicha, fermented sugar cane juice or honey that makes the workers happy. Las Marías is a rural community and in socio-cultural aspects it is not as rich as far as folklore is concerned, but they have



adopted some dances from other communities such as: the dance of the cucúa and the cumbia that is widely practiced in this region, among its foods is the guisao and the cocada.


Currently the children do not have a safe place to play and the PE teacher states, "Every day I suffer in teaching my classes because of not having a healthy and safe place for my students to teach my physical education classes, and practice sports activities. I currently teach my classes on land temporarily loaned by a lady from the community (in which) the students go through the street in danger of an accident or collision with a car, go down a hill, reach the land where we can find obstacles such as feces of animals, mud, and standing water. We have found animals like cows in the lot with high grass." Therefore, this community has identified this multi-use athletic court, built on the grounds of the school, as one of their most pressing needs.

Our group will be met at the airport by the Courts for Kids Panama Country

Director who lives in Panama and has been working closely with the community to plan all aspects of your visit. We will be staying in a community building sleeping on mattresses on the floor. The court will also be built at the school and will be used by the entire community. Many times it will be a place where the community will gather to dance and hold celebrations and ceremonies. We will work side-by-side with the locals and although it will be challenging there are jobs for every-

one of every physical capacity. During the whole trip we will be fully immersed in the local culture eating authentic food, learning local traditions, customs, and way of life. It is important to note that this court will be built <u>with</u> the community not <u>for</u> the community. The community members are very motivated to make their court a reality and from the beginning, they have been the driving factor planning this project to see it come to fruition.

- *More specific lodging, packing, and trip logistics will be provided as the departure date gets closer.
- **Please note, the destination community is subject to change at the discretion of Courts for Kids in order to best meet the needs and safety of the volunteer group as well as the needs of the host community.



Trip Safety

Courts for Kids makes your safety our number one priority. Being in a safe, tight knit community with strong awareness and ownership of the project will provide local people who will be personally invested in the safety of the team. Courts for Kids also has safety protocols in place that include, but are not limited to:

- A Courts for Kids representative will lead the group while in the destination country.
- We always contract **private transportation** to pick up and return the group to the in-country airport.
- We have a **strict behavior and conduct policy** for all trip participants which promotes the safety and security of the group. All participants are required to attend a **mandatory training**.
- We have **secure transportation** available to medical facilities in the case of any injuries.
- We will have a first aid kit with the group at all times.
- We only drink clean, potable water.
- We work with community cooks to adhere to our Safe Cooking Practices.
- We monitor the **US State Department** travel warnings and make travel adjustments as deemed necessary.
- We require all volunteers to be disconnected for the entirety of the trip. No cell phones will be allowed once in country.
- **Insurance coverage** for all trip participants that includes evacuation with a medical escort in a worst case situation. Policy details can be provided upon request.
- A Child Protection Policy which includes background checks for all adults traveling in a group where minors are present.
- Courts for Kids may conduct a **behavioral background check** through a student's school and reserves the right to refuse a participant based on the information we receive.

Safety is a team effort and every trip participant is responsible for their behavior, must use common sense while traveling, and comply with Courts for Kids representatives and trip leaders at all times.

2023 COVID Policies

- Groups and participants agree to comply with any COVID-19 vaccine or testing requirements imposed by the destination country as well as the US State Department. This may require participants to show proof of vaccination or a negative COVID-19 test* if mandated by either the destination country or the US State Department. Courts for Kids will not impose any testing or vaccine requirements beyond those of the applicable governing authorities.
- As of June 2022, the US State Department no longer requires a negative COVID-19 test for reentry to the United States.
 In the event that this requirement is re-imposed in the future, Courts for Kids will be required to introduce additional measures to ensure trip participant safety and compliance with the testing requirement. These may include the necessity for COVID-19 trip insurance and a quarantine chaperone for each trip. Groups and participants acknowledge that this may require them to incur additional costs.
- CFK will consider travel to countries identified as "Level 4" by the U.S. Department of State, provided that such level is the result of possible COVID-19 concerns. CFK will not travel to countries identified as "Level 4" due to "crime or violent activity".
- Each participant will abide by the rules and recommendations of the destination country with regards to COVID-19 safety (e.g., in regard to mask wearing, social distancing, etc.), and community-specific measures. Participants will also abide by the latest recommendations for international travel issued by the Centers for Disease Control.

^{*} If a participant tests positive and is unable to travel, there will be no refunds or credits given.

Funding Responsibilities

Everyone in your group will contribute to the total project costs. Each participant will be required to fundraise/donate this amount:

\$2,600

100% of all donations are fully tax deductible

All funds raised are applied to court construction costs and the following group expenses:

- Round trip airfare (award points cannot be used)
- In-country costs (food, water, lodging, and transportation)
- Entrance/exit fees
- Emergency medical insurance
- Special activities
- Chaperone costs
- Court construction costs (in addition to your giving, the host community also contributes making this court a reality).

Does <u>not</u> include: passport, immunizations, travel to and from the US airport, food or incidental costs on layovers and delays, or spending money for souvenirs.

*All donations are non-refundable (unless the entire project is canceled by Courts for Kids, funds will be refunded less non-recoverable costs). If you raise/donate more than the above amount, you can choose to apply the excess to passport or immunization costs (must submit receipts), the court construction costs, sports equipment, toward the balance of another trip participant or towards Courts for Kids in general. You will not be eligible for any other refunds or reimbursements due to IRS regulations.

Scholarship Opportunities

Courts for Kids is committed to providing opportunities for every student, regardless of income. If you are facing financial hardship and/or qualify for free/reduced lunch in the school district in which you live (regardless of what school you go to), we encourage you to apply to our program.

If awarded a Courts for Kids scholarship half of your trip costs will be covered and you will be expected to fundraise the other half.

Trip Checklist

- 1. **Registration**: Students will submit completed applications to Mary Rink, the Ignatian Formation Director. The applications are due **October 26th.** After all applications have been reviewed, a minimum of 16 students and a maximum of 20 will be selected to attend the trip. Upon acceptance to the program a \$500 deposit is due to Courts for Kids within 2 weeks to secure your place on the trip. - 2. **Passport:** Make sure you have a passport that will not expire before **February 4th**, **2024** If you need a passport, go to the nearest post office for assistance. **In order to avoid the headache and stress, make sure you get your passport on time, do it ASAP.**
- 3. Fundraising deadlines:
 - •Deposit of \$300 within two weeks of acceptance on the trip
 - •1st amount of \$700 by February 27th, 2023
 - •2nd amount of \$800 by April 26th, 2023
 - •3rd amount of \$800 by June 26th, 2023
- * All donations are non-refundable. If the project is canceled by Courts for Kids, donations less unrecoverable costs will be refunded.
- 3. Vaccinations: The recommended vaccinations for travel to Panama according to the Center for Disease Control are the following (keep in mind these are recommended, not required. Check with your local doctor and make the decision best for you):
- a. Routine (DPT, MMR, Polio), Hepatitis A, Hepatitis B, and COVID-19—all travelers
- b. Typhoid—most travelers
- c. Malaria and Rabies—some travelers (Yellow Fever is only recommended east of the Panama Canal and this project is west of the canal).
- 4. Parents Informational Session, via Zoom, is on **Tuesday, October 18th from 6:30–7:30 pm.**Students must attend <u>mandatory</u> Courts for Kids pre-trip training on **Sunday, May 21st from 4-7 pm** at Bellarmine. Meeting is mandatory and not attending is giving up your spot.

Online Appeal

· **Personal Fundraising Page:** Upon registration, you will receive a personal fundraising page and an email with instructions on how to customize it. Come up with a list of friends and family members to send it to. Once somebody donates, it will show up immediately in your registration page.

•Facebook/Instagram Fundraisers:

•Anyone can create a fundraiser on Facebook or Instagram, including your family members; however, <u>fundraisers must follow the rules outlined below</u>. When fundraisers are created correctly, Courts for Kids will directly receive the funds you raise and we will credit 100% of the donations towards your trip fundraising responsibilities.

Rules for Fundraising on Facebook and Instagram

Fundraiser 'titles' (on Facebook) and the text of 'donation stickers' (on Instagram) \underline{MUST} include the trip participant's first and last name or donations received through this fundraiser will \underline{NOT} be able to be credited to your trip costs.

Examples:

- •ACCEPTABLE: 'John Smith's summer Xavier HS trip to Nicaragua fundraiser' Created by John Grandmother
- •NOT ACCEPTABLE: 'Fundraiser for my summer Xavier trip to Nicaragua' created by John Smith

Fundraisers must be created for Courts for Kids, not for yourself. When creating a fundraiser, choose Courts for Kids under the 'Nonprofit' section, do not choose the option to raise money for 'Yourself' or 'For a Friend.'

Support Letters

- •Come up with a list of friends and family members who might support you on this trip. Don't rule people out too quickly. You will be very surprised at who will support you. Get their addresses.
- •Type up a support letter for people to make a tax-deductible donation on your behalf (use the sample on the next page for an idea).
- •Send the letter, pledge card and a return-addressed envelope (to your house) to everyone on your list.
 - IMPORTANT- Get this letter out ASAP to make sure you get your support raised in time.
- •Make sure people give you checks made out to Courts for Kids. When you receive a check, make sure and send them a thank you card. Next send the check **and the response card** to Courts for Kids.

Other ideas

- •If applicable, see if your home church, service club, or other organization will sponsor you.
- •Do a game night, movie night, adult prom, Zumba-thon, Bunco party or another fun event and sell tickets.
- •Solicit donations you can sell in a garage sale, silent auction, online auction, or raffle.
- •Make a craft, shirt, or food item that you can sell.
